



IMPORTANT NOTICE REGARDING UPCOMING RATE CHANGES

For over 50 years, VGS has maintained competitive and affordable rates for its 56,000+ customers. As we work to enhance our customer service and make investments in safety and Vermont's clean energy future, we are committed to keeping those rates low for current and future customers. Thus, we want to let you know about proposed rate changes.

2026 Energy Efficiency Charge Rates: Case No. 25-1126-TF

By Order dated October 31, 2025, the Commission approved an increase in the Energy Efficiency Charge ("EEC"). The EEC is used to fund the wide range of energy efficiency programs VGS offers its customers. Effective February 1, 2026, the EEC will increase by about 7.39%.

Purchased Gas Adjustment: Case No. 25-2900-TF

On November 20, 2025, VGS filed a request with the Commission for an increase in the Natural Gas charge of 3.9%, which results in an overall firm rate increase of 1.23%. The effective date of this change is dependent on the regulatory review process, but it is anticipated to take effect with bills rendered on and after February 1, 2026.

Combined, the EEC and PGA changes result in an overall rate change across all firm customers to be an increase of 1.46% which is comprised of a 3.9% increase in the Natural Gas Charge portion of your bill and a 7.39% increase in the Energy Efficiency Charge. With these changes, a typical residential customer will pay about \$1,791.47 a year for natural gas which is an increase of about \$21.05/year or approximately \$1.75/month.

As we work toward maintaining our core values of safety, climate, customers, and culture, we are committed to keeping our rates low and stable for current and future customers. Pending regulatory approval of the Purchased Gas Adjustment, rates will be adjusted as follows:
